

For residential taxpayers in Cobourg, this year's tax rate of .0084555 represents a very slight decrease from the 2016 tax rate.

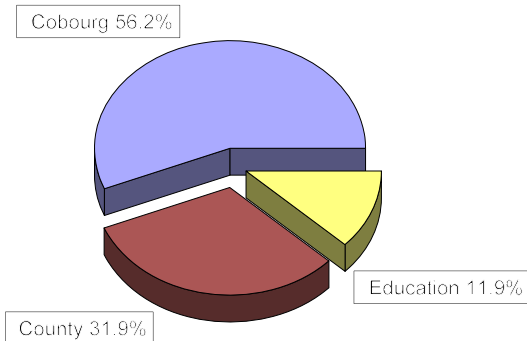
The impact of this decrease coupled with an average 0.53% assessment increase is set out below. There is also a comparison of your 2017 and 2016 tax bills on Schedule 2 of your bill.

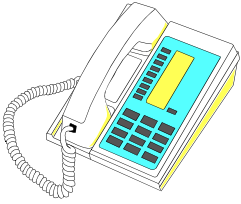
Household Hazardous Waste

Bring old paint, aerosols, diabetic insulin needles, pesticides, batteries, oil, fluorescent tubes and more to one of our four Household Hazardous Waste Depots in Northumberland County. The Cobourg Depot will be open from 8:30 a.m. - 2:00 p.m. on the following dates:

- April 5, 6 and 8
- May 3, 4 and 6
- June 7 and 10
- July 5 and 8
- August 2 and 5
- September 6 and 9
- October 4 and 7

Please no empty paint cans or containers. To find out what else you can bring to a depot or for information about additional locations and dates, please refer to your 2017 Waste & Recycling calendar, visit www.northumberlandcounty.ca or call 1-866-293-8379. Take Advantage of the **Electronics Drop-Off** at the Depots as well - TVs, computers, monitors, cell phones, VCRs and more can be brought free of charge when the Depot is open.
