## For residential taxpayers in Cobourg, this year's tax rate of .0082619 represents a slight increase from the 2020 tax rate.

The impact of this increase coupled with an average 0.163% assessment increase is set out below. There is also a comparison of your 2020 and 2021 tax bills on Schedule 2 of your bill.


