#### For residential taxpayers in Cobourg, this year's tax rate of .0083905 represents a very slight decrease from the 2017 tax rate.

The impact of this decrease coupled with an average 3.16% assessment increase is set out below. There is also a comparison of your 2018 and 2017 tax bills on Schedule 2 of your bill.

### Where do my Municipal Tax dollars go?


The Municipal portion of the median \$3,642 tax bill is \$2,056 or 56.5% of the bill. This represents a monthly charge of \$171.35.


