

For residential taxpayers in Cobourg, this year's tax rate of .0082450 represents a slight decrease from the 2019 tax rate.



Where do my Municipal Tax dollars go?

The Municipal portion of the average \$3,987 tax bill is \$2,269 or 56.9% of the bill. This represents a monthly charge of \$189.09.

Pre-authorized Payment Plan

We allow taxpayers to pay their taxes on a monthly basis, free of administration fees. An application form is enclosed or can be found on our website at www.cobourg.ca.

Online Banking/Telephone Banking

At most financial institutions, our payee name is listed as "Cobourg Tax". Your 15-digit roll number starting with zero and ending with a minimum four zeros is required for setup.

There is a 24-hour drop box located on the west side of Victoria Hall located at 55 King Street West, Cobourg, Ontario.
