- Provincial commitment to fund new firefighter certification costs so that it is not an unfunded mandate for municipal governments;
- the Province provide, in legislation, liability indemnification for all municipal governments who certify their firefighters to the standards in the Firefighter Certification regulation and that this is done at least 12 months before this regulation comes into force; the proposed Firefighter Certification regulation does not come into force;
- any earlier than January 1, 2020;
- technical amendments to the draft Firefighter Certification Community Risk Assessment occur as per the AMO attached as Appendix "A", as well as those provided in the Ontario Association of Fire Chiefs (OAFC) submission;
- the draft Public Reports regulation be held and not approved until Ontario's Standard Incident Response (SIR) framework, system improvements, and implementation strategies are discussed and consensus is achieved at the Table; and
- Medical responses are not included in any future reporting requirements for municipal funded fire services.
